It appears that earlier while disposing of SWP no.910/2013 vide order dated 28<sup>th</sup> May 2013, respondent Commission was directed to consider acting upon the clearance of petitioner's promotion in the manner Commission had acted upon *qua* other Assistant Engineers (degree holders) and take a decision in the matter within four weeks. Respondent Commission appears to have not complied with order dated 28<sup>th</sup> May 2013, constraining petitioner to re-agitate the matter.

Learned counsel for respondent no.2 states that he is yet to receive necessary inputs from respondent no.2 and therefore would not be in possession to inform the Court regarding action taken in the matter.

Adjourned at request of counsel for respondent no.2, enabling him to come up with definite information as regards compliance of order dated 28<sup>th</sup> May 2013.

Learned counsel for petitioner states that order dated 19<sup>th</sup> May 2013 has been observed in breach inasmuch as respondents, though directed not to effect confirmation to stop gap placements, have vide Government order no.246-RD&PR of 2014 dated 12<sup>th</sup> August 2014, accorded confirmation to the promotions and issued tentative seniority list. Learned counsel would be free to lay appropriate motion so that proceedings are initiated against respondents for disobedience of the Court

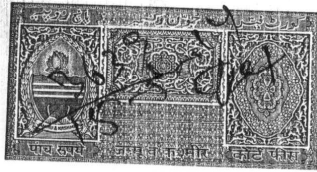
