Subject: Cancellation of Show Cause Notice issued in favour of Harooon Rashid Wani bearing Roll No.1900212.

## Order No.23-PSC of 2019 Dated:24-04-2019

Whereas, the Written Examinations for Range Officer Grade-I (Forest) was held w.e.f 23-03-2019 to 27-04-2019 both at Srinagar as well as Jammu Centres; and

Whereas, the optional paper of Silviculture/Botany/Field Crop which was being conducted on 27-03-2019 and the Supervisor, J&K PSC Examination Hall Solina Srinagar had reported that you along with other four candidates (identified by the Supervisory Staff and through video recording) lead the unruly mob of candidates and started raising slogans in front of J&K PSC gate and tried to prevent the entry of the other candidates into the Examination Hall; and

Whereas, despite these threats and intimidation, the other candidates managed their entry into the Examination Halls and the Supervisor concerned started the examination process as per the schedule by distributing the Question-Cum Answer Booklets among the present candidates; and

Whereas, you along with other four candidates who were outside the examination hall broke open the entry doors, followed by snatching and tearing off the Question Cum Answer Booklets of other candidates who otherwise were writing their answer booklets peacefully and force them to leave the examination hall; and

Whereas, due to above reasons the examination at Srinagar Centre could not be conducted and FIR stands lodged in concerned Police Station; and

Whereas, a show cause notice was issued to all the miscreants identified by the Supervisory staff; including Mr. Haroon Rashid Wani S/o Ab. Rashid Wani Roll No.1900212 and;



Whereas, in response to said notice Mr. Haroon Rashid Wani S/o Ab. Rashid Wani Roll No.1900212 cause his appearance at Srinagar Camp Office and submitted his reply along with documentary evidence in the shape of a certificate from his Department about his non-involvement and absence from J&K PSC Examination Hall, thereby pleading his non-involvement on that fateful day. He further submitted that he has not appeared in any other paper of the said examination and;

Whereas, Deputy Controller Camp Office Srinagar, on the said response informed that the candidate namely Haroon Rashid Wani bearing Roll No.1900212 was not present on that day, but was misidentified in place of another candidate of similar appearance who was in fact part of the group which was responsible for the above illegal act.

Now, therefore, in view of the above illustrated facts, the proceedings initiated under rule 21 of J&K PSC (Conduct of Examination) Rules 2005 against Mr. Haroon Rashid Wani S/o Ab. Rashid Wani Roll No.1900212 are hereby dropped.
