Whereas, Health & Family Welfare Department vide letter No. HME/HRM/64/2019 dated 19.09.2019 referred 10 posts [OM:07, RBA:01, ST:01, ALC:01] of Consultant in the discipline of Anesthesiology for selection of suitable candidates; **and**

Whereas, the Jammu & Kashmir Public Service Commission vide Notification No.12-PSC(DR-P) of 2019 dated 01.10.2019 invited online applications on prescribed format from the permanent residents of Jammu and Kashmir for Ten (10) posts of Consultant in the discipline of Anesthesiology in Health & Medical Education Department; **and**

Whereas, against the said notification the Commission received 110 applications, which were scrutinized and 95 eligible candidates were called for interview which was conducted w.e.f. 09.08.2021 to 11.08.2021 with the assistance of Experts from outside; **and**

Whereas, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980, the Commission approved the provisional select list for the posts of Consultant Anaesthesiology under Agenda item No.19.10 in its meeting held on 25.09.2021; **and**

Whereas, the provisional select list was issued vide Notification No.54-PSC (DR-S) of 2021 dated 25.09.2021 wherein, 09 candidates were selected provisionally under different categories with the stipulation that, objections, if any, may be submitted to the Commission within five days from the issuance of the provisional select list for examination/disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; **and**

Whereas, in response to the above, 02 representations have been received in the Commission as per the detail below and are accordingly disposed of with the clarification/remarks mentioned against each:

S.No	Name of the Candidate	Claim(s)	Remarks
01	Dr. Khalida Parveen	Some publication marks which were added to her merit in the previous J&K PSC list for the posts of Lecturer Anesthesiology conducted four months back have not been added this time.	The candidate has submitted 03 Publications before the Interview Board but the same were not accepted by the concerned Interview Board. The complaint, as such, is devoid of merit and merits no consideration.
02	Dr. Azka Sunain Khan	The candidate claimed that during the interview, 03 of her Publications were accepted by the Interview Board.	The candidate has submitted 03 Publications but only 01 Publication has been accepted by the concerned Interview Board. The complaint, as such, is devoid of merit and merits no consideration.
