Whereas, Health & Family Welfare Department vide letter No. HME/HRM/64/2019 dated 19.09.2019 referred 05 posts [OM:03, SC:01, ST:01] of Consultant in the discipline of E.N.T for selection of suitable candidates; **and**

Whereas, the Jammu & Kashmir Public Service Commission vide Notification No.12-PSC(DR-P) of 2019 dated 01.10.2019 invited online applications on prescribed format from the permanent residents of Jammu and Kashmir for Five (05) posts of Consultant in the discipline of E.N.T in Health & Medical Education Department; **and**

Whereas, against the said notification the Commission received 44 applications, which were scrutinized and 41 eligible candidates were called for interview which was conducted on 04.08.2021 with the assistance of Experts from outside; **and**

Whereas, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980, the Commission approved the provisional select list for the posts of Consultant E.N.T under Agenda item No.19.17 in its meeting held on 25.09.2021; **and**

Whereas, the provisional select list was issued vide Notification No.58-PSC (DR-S) of 2021 dated 25.09.2021 wherein, 05 candidates were selected provisionally under different categories with the stipulation that, objections, if any, may be submitted to the Commission within five days from the issuance of the provisional select list for examination/disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; **and**

Whereas, in response to the above, 02 representations have been received in the Commission as per the detail below and are accordingly disposed of with the clarification/remarks mentioned against each:

01	Dr. Shahnaz Sheikh	To enquire about the academic credentials, especially the Gold Medal and Paper Presentation in National and International Conferences of Saima Tabasum D/O Sh. G.M. Saroori.	As per record, the certificate of Gold Medal and Paper Presentations are attached with the application form of the concerned candidate.  <b>The complaint, as such, is devoid of merit and merits no consideration.</b>
02	Dr. Mukhtar Ahmad Khan	The candidate claimed that he has been awarded 2 points against Publications vide Notification No.74-PSC (DR-S) of 2018 dated 04.12.2018 whereas in the instant Notification only 1 point has been awarded against Publications.	The candidate has submitted 10 Publications before the Interview Board but only 04 Publications has been accepted by the concerned Interview Board.  <b>The complaint, as such, is devoid of merit and merits no consideration.</b>
