Whereas, Health & Family Welfare Department vide letter No. HME/HRM/64/2019 dated 19.09.2019 referred 11 posts [OM:07, RBA:01, SC:01, ST:01, ALC:01] of Consultant in the discipline of Gynae & Obsts for selection of suitable candidates; **and**

Whereas, the Jammu & Kashmir Public Service Commission vide Notification No.12-PSC(DR-P) of 2019 dated 01.10.2019 invited online applications on prescribed format from the permanent residents of Jammu and Kashmir for Eleven (11) posts of Consultant in the discipline of Gynae & Obsts. in Health & Medical Education Department; **and**

Whereas, against the said notification the Commission received 118 applications, which were scrutinized and 105 eligible candidates were called for interview which was conducted w.e.f. 09.08.2021 to 11.08.2021 with the assistance of Experts from outside; **and**

Whereas, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980, the Commission approved the provisional select list for the posts of Consultant Gynae & Obsts. under Agenda item No.19.06 in its meeting held on 25.09.2021; **and**

Whereas, the provisional select list was issued vide Notification No.55-PSC (DR-S) of 2021 dated 25.09.2021 wherein, 10 candidates were selected provisionally under different categories with the stipulation that, objections, if any, may be submitted to the Commission within five days from the issuance of the provisional select list for examination and disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; **and**

Whereas, in response to the above, 01 representation was received in the Commission and has been disposed of with the clarification/remarks mentioned in the remarks column below:

The name of the candidate (Sami Seema) not included in the list of candidates to be interviewed.</p> <p>iii. The maximum age limit for the post of Consultant as mentioned in the advertisement notice is 40 years. The DOB of Dr. Sami Seema is 12.03.1978.</p> | <p>The candidate was declared eligible on the basis of being In-service Certificate issued by Director, Health Services, Kashmir on 05.08.2021 and she is presently posted at SDH, Nagam as Medical officer and the age for in-service candidate was 45 years.</p> <p>Further, candidate has submitted one North Zone Yuva FOGSI Conference, 2015 which is not accepted by the concerned Interview Board being Zonal Level Conference.</p> <p><b>The complaint, as such, is devoid of merit and merits no consideration.</b></p> |
