Whereas, Health & Medical Education Department vide letter No. ME/GAZ/187/2014 dated 25.04.2019 referred 02 posts of Lecturer in the discipline of Psychiatry under Open Merit category, one each in GMC Jammu and GMC Srinagar respectively, for selection of suitable candidates; **and**

Whereas, the Jammu & Kashmir Public Service Commission vide Notification No.08-PSC(DR-P) of 2019 dated 20.05.2019 invited online applications on prescribed format from the permanent residents of Jammu and Kashmir for Two (02) posts of Lecturer in the discipline of Psychiatry in Health & Medical Education Department; **and**

Whereas, against the said notification the Commission received 21 applications [GMC-Jammu:09, GMC-Srinagar:12], which were scrutinized and 19 eligible candidates [GMC-Jammu:08, GMC-Srinagar:11] were called for interview which was conducted on 03.08.2021 with the assistance of Experts from outside; **and**

Whereas, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980, the Commission approved the provisional select list for the posts of Lecturer Psychiatry (Jammu/Srinagar) under Agenda item No.19.7 in its meeting held on 25.09.2021; **and**

Whereas, the provisional select list was issued vide Notification No.60-PSC (DR-S) of 2021 dated 25.09.2021 wherein, 02 candidates were selected provisionally under Open Merit Category with the stipulation that, objections, if any, may be submitted to the Commission within five days from the issuance of the provisional select list for examination and disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; **and**

Whereas, in response to the above, 01 representation was received in the Commission and has been disposed of with the clarification/remarks mentioned in the remarks column below:

01	Dr. Rameshwar Singh Manhas	<p>Following allegations have been leveled against the candidate namely Dr. Abhishek Chowhan that:-</p> <p>i. Dr. Abhishek Chowhan was given 2 marks for the book publication and no such book was found by me during the internet search.</p> <p>ii. He was assigned Total viva marks of 26 which is probably due to some miscalculation.</p>	<p>As per record, the candidate has submitted two books and the same were accepted by the concerned Interview Board.</p> <p>Further, after scrutiny from the Award Roll, the marks awarded against viva-voce found correct.</p> <p>The complaint, as such, is devoid of merit and merits no consideration.</p>
