Whereas, Health & Medical Education Department vide letter No. ME/GAZ/187/2014 dated 25.04.2019 referred 01 post of Lecturer in the discipline of Social & Preventive Medicine (GMC-Srinagar) under Scheduled Tribe Category for selection of suitable candidate; **and**

Whereas, the Jammu & Kashmir Public Service Commission vide Notification No.09-PSC(DR-P) of 2019 dated 08.07.2019 invited online applications on prescribed format from the permanent residents of Jammu and Kashmir for One (01) post of Lecturer in the discipline of Social and Preventive Medicine in Health & Medical Education Department; **and**

Whereas, against the said notification the Commission received 02 applications, which were scrutinized and accordingly both the candidates were found eligible and accordingly called for interview which was conducted on 31.07.2021 with the assistance of Experts from outside; **and**

Whereas, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980, the Commission approved the provisional select list for the posts of Lecturer in the discipline of Social and Preventive Medicine (GMC-Srinagar) under Agenda item No.19.11 in its meeting held on 25.09.2021; **and**

Whereas, the provisional select list was issued vide Notification No.66-PSC (DR-S) of 2021 dated 25.09.2021 wherein, 01 candidate under ST Category was selected provisionally with the stipulation that, objections, if any, may be submitted to the Commission within five days from the issuance of the provisional select list for examination/disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; **and**
