Whereas, Health & Medical Education Department vide letter No. ME/Gaz/149/2017, ME/Gaz/150/2017, ME/Gaz/151/2017, ME/Gaz/152/2017 and ME/Gaz/153/2017 dated 11.01.2018 referred 02 posts of Assistant Professor (Lecturer) in the discipline of Surgery in different Govt. Medical Colleges as per following breakup for selection of suitable candidates:-

Whereas, J&K Public Service Commission vide Notification No. 10-PSC (DR-P) of 2019 dated 08.07.2019 advertised the said posts for selection of suitable candidates; **and**

Whereas, Commission received 02 applications [GMC-Anantnag: 01, GMC-Baramulla:01], which were scrutinized and accordingly eligible candidates were called for interview. Only one candidate has applied for both GMC Anantnag as well as GMC Baramulla.; **and**

Whereas, the interview of the shortlisted candidates was conducted on 16.09.2021 with the assistance of experts; **and**

Whereas, one post under SC category in GMC Baramulla has been left vacant due to non-availability of candidates.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, **Dr. Varinder Paul S/O Sh. Bansi Lal R/O Ward No.1, House No.136, Kashmiri Mohalla, Akhnoor** securing **56.24 points** is selected against the post of Assistant Professor (Lecturer) Surgery under SC Category in GMC Anantnag.
