Subject : Show Cause Notice.

Whereas, the Jammu and Kashmir Public Service Commission invited online applications for the J&K Combined Competitive (Preliminary) Examination, 2021 from eligible domiciles of the Union Territory of Jammu and Kashmir vide Notification No. 02-PSC(DR-P) of 2021 dated: 26.02.2021;

Whereas, in response to the Notification, you applied for appearing in the said Examination. Your application form was accepted and you were allotted Roll No. 9108001;

Whereas, you appeared in the said Examination at Srinagar on 24.10.2021;

Whereas, after the smooth conduct of the Examination throughout the Union Territory, the Provisional Official Key vide Notification No. PSC/Exam/2021/57 dated 25.10.2021 was published for inviting objections to the same from the candidates. No objection to the Provisional key has been received by the Commission from you.;

Whereas, after processing the objections received from the candidates, the Final Official Key was published vide Notification No. PSC/Exam/2021/59 dated: 13.11.2021 along with the Result Notification No. PSC/Exam/2021/60 dated: 13.11.2021 according to which you have not qualified for the Combined Competitive (Mains) Examination, 2021;

Whereas, after failure in the said Preliminary Examination, you approached the Commission on 15.11.2021, through your father Mr. Abdul Gani Ganie, submitting a photocopies of the candidate's copy of the OMR sheets retained by you alleging the result process to be erroneous, thereby, raising doubts on the credibility of the process adopted by the Commission for the said Examination, besides questioning the fairness and impartiality of the Commission;

Whereas, upon verification of the facts by referring to the original record, i.e., OMR sheets filled by you, it was found that the copies submitted by you

(through your father) have been tampered as the responses marked by you in the original OMR sheets do not match with the insertions made by you in the candidate's copy of the OMR sheet, which amounts to misrepresentation of facts and suppressing material information, besides a willful attempt to malign with dishonest intent the exam conducting body.

Whereas, taking a serious note of this misconduct on your part, the Commission has decided to initiate disciplinary proceedings against you under relevant provisions of the J&K Public Service Commission (Conduct of Examination) Rules, 2005, which may call for criminal proceedings under relevant provisions of the law and may also lead to you being debarred from appearing in future examinations;

You are, therefore, directed to report at the office of the Controller of Examinations, J&K Public Service Commission, Resham Ghar Colony, Bakshi Nagar, Jammu on **25**.11.2021 and explain your position in this regard and show cause as to why disciplinary proceedings may not be initiated against you, failing which, disciplinary action under relevant rules shall follow.
