Whereas, the Jammu & Kashmir Public Service Commission vide Notification No.12-PSC(DR-P) of 2019 dated 01.10.2019 invited online applications on prescribed format from the permanent residents of Jammu and Kashmir for Seven (07) posts of Consultant in the discipline of Pediatrics in Health & Family Welfare Department; **and**

Whereas, against the said notification the Commission received 66 applications, which were scrutinized and 58 eligible candidates were called for interview which was conducted on 12.08.2021 and 13.08.2021 with the assistance of Experts from outside; **and**


Whereas, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980, the Commission approved the provisional select list for the posts of Consultant Paediatrics under Agenda item No.19.02 in its meeting held on 25.09.2021; **and**

Whereas, the provisional select list was issued vide Notification No.56-PSC (DR-S) of 2021 dated 25.09.2021 wherein, 06 candidates were selected provisionally under different categories with the stipulation that, objections, if any, may be submitted to the Commission within five days from the issuance of the provisional select list for examination/disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; **and**

Points have been awarded for the experience gained from Fortis Hospital, SDH Sopore and DSH Baramulla only. Experience gained from Chaitanya Hospital, Shri Sai Multi Specialty Hospital, HP and Dhami Hospital and Trauma Centre, Hoshiarpur have not been considered for being Private Institutions and the experience certificate have also not been countersigned by any Competent Government Authority.
