Whereas, in response to the said Notice, the Commission has received 09 representations from the following candidates, the response whereof against each representation is given in the remarks column below:


#	Name of the candidate	Remarks
1.	Akhtar Niyaz Bhat	The representation has been examined and the candidate is eligible for short listing.
2.	Lateef Ahmad Rather	As per the decision of the Equivalence Committee, PG in Electronic Media is not equivalent with the prescribed qualification. Hence, representation is rejected.
3.	Umer M Malik	As per the decision of the Equivalence Committee, PG in Electronic Media is not equivalent with the prescribed qualification. Hence, representation is rejected.
4.	Tabeena Anjum	The candidate does not possess NET/SET/SLET. Her Ph. D Degree has been consumed towards eligibility; therefore, no points can be awarded for the Ph. D degree separately. Hence, representation is rejected
5.	Arshi Showkat	Experience certificate issued after the cutoff date cannot

		be considered.
6.	Saqib Ahmad Wani	The candidate has already been awarded 02 points for experience. Experience gained in the different discipline cannot be considered. Hence, representation is rejected.
7.	Mohd Afzal Sofi	The candidate is not entitled for any weight-age for the experience which is not in relevant discipline. Hence, rejected.
8.	Heeba Din	The representation of the candidate has been considered and found entitled for 01 point for gold medal.
9.	Abdul Raof Mir	Representation of the candidate has been considered and found entitled for 0.50 marks in PG on the basis of conversion formula.
