Whereas, Health & Medical Education Department vide letter No. ME/GAZ/187/2014 dated 25.04.2019 referred 01 post of Lecturer under Open Merit Category in the discipline of Ophthalmology (GMC-Jammu) for selection of suitable candidate; **and**

Whereas, the Jammu & Kashmir Public Service Commission vide Notification No.08-PSC(DR-P) of 2019 dated 20.05.2019 invited online applications on prescribed format from the permanent residents of Jammu and Kashmir for Lecturer in the discipline of Ophthalmology in Health & Medical Education Department; **and**

Whereas, against the said notification the Commission received 21 applications, which were scrutinized and 18 eligible candidates were called for interview which was conducted on 02.08.2021 and 03.08.2021 with the assistance of Experts from outside; **and**

Whereas, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980, the Commission approved the provisional select list for the posts of Lecturer in the discipline of Ophthalmology under Agenda item No.20.5 in its meeting held on 03.11.2021; **and**

Whereas, the provisional select list was issued vide Notification No.88-PSC (DR-S) of 2021 dated 03.11.2021 wherein, 01 candidate was selected provisionally under Open Merit Category with the stipulation that, objections, if any, may be submitted to the Commission within five days from the issuance of the provisional select list for examination and disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; **and**

Whereas, in response to the above, 01 representation was received in the Commission and has been disposed of with the clarification/remarks mentioned in the remarks column below:

i. The 4.50 marks awarded for Publications in favour of Dr. Vijayata Gupta are for publication which have neither been published, nor authored by the candidate. The candidate has also submitted her thesis publications which are not eligible for consideration as per the norms. Some of the Publications are not available in public domain and yet have been considered.

ii. The candidate is eligible for 1 mark for teaching experience, however, she has been awarded 1.50 marks for the same.

iii. The candidate has secured 2


