Whereas, Health & Family Welfare Department vide letter No.HME/HRM/64/2019 dated 19.09.2019 referred 22 posts (OM: 14, RBA: 03, SC: 02, ST: 02 & SLC: 01) of Consultant in the discipline of Medicine for selection of suitable candidates; **and**

Whereas, the Jammu & Kashmir Public Service Commission vide Notification No.12-PSC(DR-P) of 2019 dated 01.10.2019 invited online applications on prescribed format from the permanent residents of Jammu and Kashmir for twenty two (22) posts of Consultant in the discipline of Medicine in Health & Family Welfare Department; **and**

Whereas, the Commission received 174 applications, which were scrutinized and 151 eligible candidates were called for interview which was conducted w.e.f. 13.09.2021 to 16.09.2021 with the assistance of Experts from outside; **and**


Whereas, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980, the Commission in its meeting held on 03.11.2021 in the Agenda Item No. 20.2 approved the provisional select list for the posts of Consultant Medicine; **and**

Whereas, the provisional list was issued vide Notification No.78-PSC(DR-S) of 2021 dated 03.11.2021 wherein 22 candidates were selected provisionally under different categories with the stipulation that objections if any, may be submitted to the Commission within five days from the issuance of the provisional select list for examination/disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; **and**
