## NOTICE Dated: ₀3-12-2021

Whereas, the Health & Family Welfare Department vide letter No.HME/HRM/64/2019 dated 19.09.2019, referred 20 posts (OM: 14, RBA: 02, SC: 01, ST: 02 & ALC: 01) of Consultant in the discipline of Surgery for selection of suitable candidates; *and* 

Whereas, the Jammu & Kashmir Public Service Commission advertised these posts vide Notification No.12-PSC (DR-P) of 2019 dated 01.10.2019 and 186 applications were received which were scrutinized and, 175 eligible candidates were called for interview which was conducted w.e.f. 13.09.2021 to 16.09.2021 with the assistance of Experts from outside•

Whereas, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980, the Commission in its meeting held on 03.11.2021 in the Agenda Item No. 20.3 approved the provisional select list for the posts of Consultant Surgery; and

Whereas, the provisional list was issued vide Notification No.77-PSC(DR-S) of 2021 dated 03.11.2021 wherein 20 candidates were selected provisionally under different categories with the stipulation that objections if any, be submitted to the Commission within five days from the issuance of the provisional select list for examination/disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; *and* 

Whereas, in response to the above, 04 representations have been received in the Commission as per the details below and are, accordingly, disposed of with the clarification/remarks indicates against each:-

Shahnawaz Mansoor Shah	The candidate has stated that 05 publications have been accepted by the board, but as per annexure "A" to Notification No.77-PSC(DR-S) of 2021, dated 03.11.2021 only <b>01 point</b> has been awarded to his 05 accepted publications instead of <b>1.25 points</b> .	On verification of the documents, it was found that one of the publication title (ESWL) VERSUS URETERO RENOSCOPIC LITHOTRIPSY (URSL) FOR MANAGEMENT OF UPPER URETERIC CALCULI, has been accepted as a paper presentation also by the Interview Board. No dual benefit can be granted to a candidate.  The complaint as such

03.	Irfan Nazir	The candidate has stated that 13 publications have been shown but only 10 publications are being shown in marks split in the annexure "A".	The assessment of the special attributes is the exclusive domain of the experts on the interview board. The experts have accepted only 10 publications out of 13 for which points stands awarded. The complaint as such
04.	Mangoor	CAT Order detect 12 10 2021	merits no consideration.
04.	Manzoor Ahmad Lone S/o. Nazir Ahmad Lone	CAT Order dated 12.10.2021 "In view of the limited prayer made by the learned councel for the applicant, the OA disposed of with directions to the respondents to treat this OA as representation of the applicant and dispose of the same by passing a reason and speaking order within 15 days from the date of receipt of certified copy of this order. A copy of the speaking order, so passed by given to the applicant. Till such time, the speaking order is passed, one post of Consultant Surgeon in Open Merit Category be kept reserved".	In compliance to CAT Order dated 12.10.2021, the applicant case has been considered and it has been found that the experience certificate submitted by the applicant was not authenticated either by CMO or Director Health as was done in the cases of other eligible candidates. Infact, the applicant was given ample opportunity even on the date of interview as well to have his experience certificate authenticated but he failed to do so, as such was not interviewed being ineligible. Moreover, the applicant was never shortlisted in the interview notice, infact another candidate with same name as the applicant, who was otherwise fully eligible was shortlisted and interviewed.
