Whereas, the J&K Public Service Commission vide Notification No. 06-PSC(DR-P) of 2018 dated 13.03.2018 invited on line applications from the permanent residents of Jammu and Kashmir for 04 posts (OM=02, RBA =01 and SC= 01) of **Associate Professor, school of Architecture** in the Higher Education Department ; and

Whereas, in response to the above advertisement notification the Commission received 06 application forms and after scrutiny of the documents the candidature of 03 candidates was rejected and 03 candidates were found deficient in respect of documents. Accordingly, vide Notice dated 02.01.2019, the candidates in respect of whose deficiency of documents was noticed were advised to submit their deficient documents within 10 days from the issuance of Notice and , the candidates whose candidature was rejected were provided an opportunity to represent before the Commission within 10 days if aggrieved with the rejection of their candidature; and

Whereas, in response to the above notice, the documents were received from the candidates, which were again verified/scrutinized for the short-listing of the candidates and only one candidate ,namely ,Sher Ali has been found provisionally eligible.
