**Subject: Select List for the posts of Horticulture Development Officer in Agriculture Production Department.**

## Notification No. 94 – PSC (DR-S) of 2021

**Dated: 07.12.2021**

Whereas, Agriculture Production Department vide letter No.Agri/Horti/98/96/2005-G-II dated 17.08.2005 & No.Agri/Horti/07-B/09 dated 02.02.2009 referred 10 posts [RBA:05, ST:03, SLC:01, PHC:01] (1st Special Drive) of Horticulture Development Officer in accordance with SRO 161 dated 23.04.2002 for selection of suitable candidates. The prescribed qualification for the said post is as under:

**“M.Sc. Horticulture in case of non-availability B.Sc. Horticulture/B.Sc. Agriculture”; and**

Whereas, J&K Public Service Commission vide Notification No. 24-PSC of 2011 dated 09.12.2011 advertised the said posts for selection of suitable candidates. The last date for receipt of applications was **09.01.2012** against which the Commission received 171 applications, which were scrutinized and accordingly 29 eligible candidates were shortlisted for interview in terms of Rule 40 of J&K Public Service Commission (Business & Procedure) Rules, 1980.

Whereas, in the meanwhile, below mentioned petitions were filed by the aspiring candidates.

- i. **SWP No.2570/2011 titled Mohd. Sadeeq Vs State and Others.**  
**The Hon'ble High Court directed as under:**

***“Subject to the objections and till next date before the bench, one post of Horticulture Development Officer under ST Category in the Agriculture Production Department shall not be filled up.”***

- ii. **SWP No.919/2012 titled Khurshied Ahmad Zargar and Others Vs J&K PSC and another.**

***“In the meantime, selection process initiated shall not be finalised till next date before the Bench.”***

Whereas, the interview of the shortlisted candidates was conducted on 26.05.2012 with the assistance of experts.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the merit of the candidates who have appeared in the interview is enclosed as **Annexure-“A”** to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

**Note:-**

1. The Commission reserves the right to have certificates/documents of the candidate verified, if at any later stage found expedient to do so. The Selection of the candidate is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.
2. The select list is provisional and objection, if any, may be submitted to the Commission within five days for examination and disposal. No claim, whatsoever, shall be entertained after five days from the date of issuance of Notification.
