Whereas, Health & Medical Education Department referred 05 posts in the discipline of Assistant Professor (Lecturer) Biochemistry one each under Open Merit in GMC (Anantnag, Baramulla, Kathua, Doda & Rajouri) vide letter No.ME/GAZ/149/2017 dated 11.01.2018, ME/GAZ/150/2017 dated 11.01.2018, ME/GAZ/151/2017 dated 11.01.2018, ME/GAZ/152/2017 dated 11.01.2018 and ME/GAZ/153/2017 dated 11.01.2018 for recommendation of selection of suitable candidates; **and**

Whereas, the Commission notified these posts vide Notification No. 01–PSC(DR-P) of 2018 dated:17.01.2018; **and**

Whereas, in response to the above notification, 45 applications were received out of which 18 candidates were found eligible and called for interview; **and**

Whereas, the interview of the eligible candidates was conducted on 19.09.2018 with the assistance of experts from outside the state; **and**

Whereas, 05 more candidate were allowed to participate in the interview on the directions of the Hon'ble High Court in SWP No.310/2018 titled Farooq Ahmad Sheikh v/s J&K Public Service Commission & Anr, SWP No.1922/2018 titled Mohit Thalquotra v/s J&K & Others and SWP NO.2219/2018 titled Showkat Ahmad Bhat v/s J&K & Others. The operative parts of the directions are reproduced as under:-

SWP No.310/2018 titled Farooq Ahmad Sheikh v/s J&K Public Service Commission

“Respondent-Commission shall accept the application form of the petitioner without insisting for filling online provided he is covered by Note-2 of the Advertisement notice then to consider his candidature in accordance with the terms of the Government Order No. 500-GAD of 2000 dated: 21.12.2000.”

SWP No.1922/2018 titled Mohit Thalquotra v/s J&K & Others

“Meanwhile, the petitioner shall be permitted to participate in the interview for the post of Assistant Professor scheduled to be conducted by respondent No. 03 on 19.09.2018 at his own risk and responsibility.

confer any right or equity in favor of the petitioner and the result of the petitioner shall not be declared till further orders from this Court.”

SWP No.1922/2018 titled Showkat Ahmad Bhat v/s J&K & Others

“It is directed that the respondents shall allow the petitioners to appear in the interview to be conducted on 19.09.2018 for the post of Assistant Professor (Lecturer) in the discipline of Bio Chemistry at his own risk and responsibility.”

Now, therefore, on the basis of performance in the interview and the weightage earned in respect of academic merit, qualifications, experience etc. and the overall performance, the Merit of the candidates who appeared in the interview is enclosed as **Annexure-“A”** to this Notification.

Consequent upon the above, the **select list** of the candidates against the available post is given in **Annexure-B** to this Notification.

1. The Commission reserves the right to have certificates/documents of the candidate verified, if at any later stage found expedient to do so. The Selection of the candidate is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.
