Subject: Interview Notice for the post of Assistant Professor, Television & Film Making notified vide Notification No. 10-PSC (DR-P) of 2017 dated 27-10-2017.

Whereas, the Jammu & Kashmir Public Service Commission vide Notification No. 10-PSC (DR-P) of 2017 dated 27-10-2017 invited online applications for 12 posts (OM=06, RBA=03 post, SC=01, ST=01 & ALC=01) of Assistant Professor, **Television and Film Making**, on prescribed format, from the permanent residents of Jammu & Kashmir; and

Whereas, the cut off merit under various categories alongwith the names of the eligible candidates was notified vide Notice dated 01-10-2021 with the stipulation that, if any candidate feels aggrieved with respect to the cut off merit and his/her non-inclusion in the eligibility list, he/she may represent before the Commission within 10 days from the date of issuance of the Notice; and

Whereas, in response to the said Notice, the Commission received 09 representations. After examination/scrutiny of these representations, while Mr. Akhter Niyaz Bhat was found provisionally eligible for shortlisting, Ms. Heeba Din was found entitled for 01 point for Gold Medal & Mr. Abdul Raoof was found entitled for 0.50 marks in P.G, on pro-rata basis on the basis of conversion formula. Accordingly, the merit was redrawn. Further the status of the disposal of these representations was Notified vide Notice dated 16.11.2021 with the stipulation that if any candidate feels further aggrieved, he/she may represent before the Appellate Authority of the Commission within 03 days from the date of issuance of this Notice.

Whereas, in response to the above said Notice, 06 appeals were received in the Commission and placed before the Appellate Authority, out-of which 02 appeals were not accepted, 04 appeals were accepted which resulted in further change in the merit as also inclusion/exclusion of certain candidates in the shortlist. The revised cut-off merit in open category now remains as 25.34.

Now, therefore, it is hereby notified that the interview of the following shortlisted candidates who have applied under Notification No. 10-PSC (DR-P) of 2017 dated 27.10.2017 for the post of Assistant Professor, **Television & Film Making**, in Higher Education Department shall be held w.e.f 29th & 30th of December 2021 at J&K Public Service Commission Office Complex, Resham Garh, Jammu as per the schedule given below:-


1. The candidature of all the candidates is purely provisional.
