Whereas, Health & Medical Education Department vide letter ME-GAZ/207/2004-Part-II dated 02.04.2019 referred 01 post of Lecturer under Open Merit Category in the discipline of Prosthodontics (GDC-Srinagar) for selection of suitable candidate; **and**

Whereas, the Jammu & Kashmir Public Service Commission vide Notification No. 06-PSC (DR-P) of 2019 dated 22.04.2019 invited online applications on prescribed format from the permanent residents of Jammu and Kashmir for one (01) post of Lecturer in the discipline of Prosthodontics in Health & Medical Education Department; **and**

Whereas, against the said notification the Commission received 08 applications, which were scrutinized and 06 eligible candidates were called for interview which was conducted on 20.09.2021 with the assistance of Experts from outside; **and**

Whereas, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980, the Commission approved the provisional select list for the posts of Lecturer Prosthodontics under Agenda item No.20.11 in its meeting held on 03.11.2021; **and**

Whereas, the provisional select list was issued vide Notification No.80-PSC (DR-S) of 2021 dated 03.11.2021 wherein, 01 candidate namely Dr. Imtiyaz Ahmad Zarger was selected provisionally under Open Merit Category with the stipulation that, objections, if any, may be submitted to the Commission within five days from the issuance of the provisional select list for examination/disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; **and**

Whereas, in response to the above, 02 representations have been received in the Commission as per the detail below and are accordingly disposed of with the clarification/remarks mentioned against each:
