It is hereby notified for information of the general public that following amendments are hereby inserted in the existing Rule 44(iv)(c), 45(iii)(b) & 30 (i) of Jammu and Kashmir Public Service Commission (Business & Procedure) Rules, 2021:-

**(i) Insertion of proviso (vi) in Rule 44(iv)(c) after part (v) under heading Guidelines:-**

*“(vi) The publication/research paper/articles forming part of P.G./DM/M.Ch and its equivalent (dissertation/thesis) shall not count for grant of weightage.”*

**(ii) Insertion of proviso (vi) in Rule 45(iii)(b) after part (v) under heading Guidelines:-**

*“(vi) The publications/research papers/articles forming part of M.Phil (dissertation) and Ph.D (thesis) shall not count for grant of weightage.”*

**(iii) Insertion of proviso in Rule 30(i):-**

*“Provided, where the Commission considers that the number of candidates who have applied for the post/(s) to be filled up by Direct Recruitment on the basis of a written Competitive Examination followed by oral interview is large and it is not convenient or expedient for the Commission to call all the candidates for the written (Mains) Competitive Examination, a screening test may be conducted on a case to case basis with the prior approval of the Commission to shortlist the candidates and the number of the candidates to be admitted to the Mains Written Examination shall be, as far as*

*practicable, one -third (1/3) of the total number of candidates who appeared in the Screening Test or 25 times the total number of vacancies to be filled, whichever is lower."*
