Whereas, Agriculture Production Department vide letter No.Agri/Horti/7-B/2009 dated 11.06.2013 referred 22 posts (OM: 17, RBA: 02, SC: 01, ST: 01 & ALC: 01) of Horticulture Development Officer for selection of suitable candidates; **and**

Whereas, the posts were advertised vide Notification No.10-PSC(DR-P) of 2013 dated 20.06.2013 and 266 applications were received. Upon scrutiny of the documents of the candidates, 76 eligible candidates were called for interview which was conducted w.e.f. 29.03.2016 to 31.03.2016 with the assistance of Experts from outside the State; **and**

Whereas, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980, the Commission in its meeting held on 03.11.2021 approved the provisional select list for the posts of Horticulture Development Officer; **and**


Whereas, the provisional select list was issued vide Notification No.86-PSC(DR-S) of 2021 dated 03.11.2021 wherein 22 candidates were selected provisionally under different categories, with the stipulation that objections, if any, be submitted to the Commission within five days from the issuance of the provisional select list for examination/disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; **and**

Whereas, in response to the above 04 representations have been received in the Commission as per the details below and are, accordingly, disposed of with the clarification/remarks indicated against each:-

01	Mohammad Muzamil Salmani	The candidate has stated that his weightage points for experience have not been mentioned/calculated and may have got skipped due to human error. Further, he has also stated that 03 years of relevant experience in the filed of horticulture and similar experience has been counted and weightage points given for	As per check sheet, no points against experience have been awarded to the candidate at the time of interview. The checksheet has been duly signed by the candidate. Therefore, the representation merits no consideration.

		serial No.4, 11, 13, 18, 32,37, 40 & others in Annexure-A of Notification No.86-PSC9DR-S) OF 2021, dated 03.11.2021. so, he has requested to kindly give him also for experience and re-calculate his merit.	
02	Arshid Ahmad Pal	The applicant has stated that his experience certificate points not included, at the time of application submitted for advertisement he had submitted three years experience certificate and the experience certificate points shown against various selected candidates. So in this connection, he has requested to kindly include his experience certificate points, so that his merit will up in the selection list.	As per the check sheet, which has been duly signed by the candidate at the time of interview, no point against experience has been awarded to the candidate. One experience certificate from 06.11.2010 to 31.03.2014 issued by ICAR was attached with the application form which has been issued after the cut off date i.e 23.03.2015, therefore, has not be considered. <u>The representation merits no consideration.</u>
03	Javid Ahmad Dar	The applicant stated that his name is figuring on S.No. 58 in Annexure "A" to Notification No. 86-PSC (DR-S) of 2021 dated 03.11.2021 and one of the selected candidate namely Arshad Ahmad Pal S/o Mohd. Abdullah Pal is figuring at S.No.56. Further, the applicant has also stated that the selected candidates on S.No.56 is falling in OM merit after calculating the points of experience certificate which was submitted by the candidate. In view of the above, the applicant has requested to kindly include the points of experience certificate in favour of Arshad Ahmad Pal S/o Mohd. Abdullah Pal at S.No.1 under RBA category, so that after calculation of experience certificate points, the candidate will fall in Open Merit category and his name will be selected under RBA category.	The cut of merit under OM Category is 65.73, while-as the merit of Arshad Ahmad Pal under RBA Category is 63.14.He has no grievance. <u>Therefore, the representation merits no consideration.</u>
