Whereas, the Agriculture Production Department vide letter No. Agri/Horti/98/96/2005-G-II dated 17.08.2005 & No. Agri/Horti/07-B/09 dated 02.02.2009 referred 10 posts [RBA: 05, ST: 03, SLC:01 & PHC:01] (1st Special Drive) of Horticulture Development Officer in accordance with SRO 161 dated 23.04.2002 for selection of suitable candidates; and

Whereas, the posts were advertised vide Notification No.24-PSC of 2011 dated 09.12.2011 and 171 applications were received. Upon scrutiny of the documents of the candidates, 29 eligible candidates were called for interview which was conducted on 26.05.2012 with the assistance of Experts from outside UT; and

Whereas, the provisional select list was issued vide Notification No.94-PSC(DR-S) of 2021, dated 07.12.2021 wherein 10 candidates were selected provisionally under various Categories, with the stipulation that objections, if any, be submitted to the Commission within five days from the issuance of the provisional select list for examination/disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; and

In response to the above Notification, only 01 representation has been received in the Commission as per the details below and is, accordingly, disposed off with the clarification/remarks as indicated:-

Mr. Ved Parkash Bhagat	The applicant has stated that he had applied for the post of HDO vide Notification No. 24-PSC of 2011 dated 09.12.2011 under PHC category and the selection was published by the Commission on 07.12.2021, but the post against the PHC category has been kept on hold due to some reasons better known to Commission. In view of the above, the applicant has requested to kindly declare the selection list on hold PHC position.	One post under PHC category has been kept withheld subject to further clarification from the indenting department.
