Whereas, the Health & Medical Education Department vide letter Nos (i) Me/Gaz/ 149/ 2017 dated 11-01-2018, (ii) Me/Gaz/150/2017 dated 11-01-2018, (iii) Me/Gaz/151/2017 dated 11-01-2018, (iv) Me/Gaz/2017 dated 11-01-2018 and (v) Me/Gaz/153/2017 dated 11-01-2018 of Assistant Professor in the discipline of Bio-Chemistry GMC Anantnag, Baramulla, Kathua, Doda and Rajouri.

Whereas, the posts were advertised vide Notification No.01-PSC (DR-P) of 2018 dated 17.01.2018 and 45 applications were received. Upon scrutiny of the documents of the candidates, 18 eligible candidates alongwith 05 candidates under Court orders, were called for interview which was conducted on 19.09.2018 with the assistance of Experts from outside UT; *and*


Whereas, the provisional select list was issued vide Notification No.95-PSC (DR-S) of 2021, dated 07.12.2021 wherein 05 candidates were selected provisionally under different categories with the stipulation that objections, if any, be submitted to the Commission within five days from the issuance of the provisional select list for examination/disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; *and*

In response to the above Notification, 02 representation (one joint at serial No. 02) have been received in the Commission as per the details below and are, accordingly, disposed off with the clarification/remarks indicated against each:

S.No.	Name of Candidate	Grievance of the candidate	Remarks
1.	Dr. Mosin Saleem	The candidate has requested to recommend his posting in GMC Anantnag instead of GMC Baramulla as he has given first preference for GMC Anantnag.	As per check sheet the doctor has given first preference for GMC Baramulla. Accordingly, he has been selected for the post of Biochemistry in GMC Baramulla, as per his preference/merit. Therefore, representation merits no consideration.
2.	Showkat Ahmad Bhat & Hilal Ahmad Wani.	The candidates have submitted a joint representation in the Commission that they were eligible for the post of Assistant Professor (Lecturer) Biochemistry in GMC Anantnag advertised vide Notification No. 01-PSC(DR-P) of 2018 dated	The candidates had not been shortlisted for the interview as they were not found to be fulfilling the eligibility requirements. However, they were allowed to appear in the interview in compliance to the directions issued by the Hon'ble Court. Therefore, representation merits no consideration.
