Subject:- Revised Select list under OM Category, for the posts of Assistant Professor (Bio-Technology) in Higher Education Department.

Whereas, the Higher Education Department vide letter HE-Coll/COORD/APPTT/AP/2017 dated 18.10.2017 among other categories posts, referred 07 posts of OM category of Assistant Professor in the discipline of Bio-Technology for selection of suitable candidates; and

Whereas, J&K Public Service Commission vide Notification No.10-PSC(DR-P) of 2017 dated 27.10.2017 advertised the said posts for selection of suitable candidates; and

Whereas, Commission received 287 applications against the above OM category posts which were scrutinized and 21 eligible candidates were called for interview; and

Whereas, the interview of the shortlisted candidates alongwith other categories candidates was conducted on 20.09.2021 & 21.09.2021 with the assistance of experts; and

Whereas, a report was published on 23th December-2021 in the media (Mountain Link) that three candidates who had secured less points than the requisite cut of merit point had been called in for interview and that 02 of them have been selected; and


Whereas, the position was checked/verified with reference to records and it has been found that the three candidates, namely Asif Amin, Pankaj Sharad & Usha Kiran have been inadvertently awarded points for JRF at the time of shortlisting, when they were not entitled to these points as they were actually not in possession of the JRF Certificate. Due to this inadvertent error, the merit of the OM category candidates, namely, Pankaj Sharad and Asif Amin got raised above the cut of merit which is 34.92. However, Ms Usha Kiran of SC candidate was still within the cut of merit even without JRF points; and

Whereas, vide Notice dated 12.01.2022, the names of Shri Pankaj Sharad and Shri Asif Amin (OM Candidates) have accordingly been deleted from the shortlisting Notice issued under endorsement No.PSC/DR/AP-Bio-Technology/HE/2019 dated 05.08.2021 and the Interview Notice dated 11.09.2021.

Now, therefore, consequent upon the above, the revised select list under OM category is re-drawn as under:-
