Subject: Rejection of candidature.

ORDER
DATED: 23 .02.2022.

WHEREAS, online application for 91 posts of Assistant Registrar, Cooperative Societies in different categories referred by Cooperative Department were invited from the eligible candidates possessing prescribed /academic professional qualification in the Union Territory of J&K; and

WHEREAS, the last date for filling up of the application forms was 16.06.2021. Mr. Sohail Choudhary, Roll No. 5130620 also applied for the said post. The candidate in his application form has mentioned the result date of his bachelors' degree as 07.06.2021; and

WHEREAS, the interview of the candidates who had qualified the written test for the post of Assistant Registrar Cooperative was scheduled from 03.02.2022 till 24.02.2022. The interview of Mr. Sohail Choudhary, Roll No. 5130620 was fixed on 23.02.2022; and

WHEREAS, on scrutiny of original certificates on the day of interview, it was found that the candidate has obtained his Bachelors' Degree after cut-off date which makes him ineligible for the said post; and

WHEREAS, at point No. 14 of advertisement Notification it has specifically been mentioned that any candidate should not furnish any particulars that are false or suppress any material information, to be disqualified by the Commission from the selection for which he/she is a candidate; and

WHEREAS, at Note 'd' of the Notice dated 27.01.2022, where under the candidates had been called for presenting themselves for the interview for the post of Assistant Registrar Cooperative Societies, it has been made clear that the candidature of all the candidates is purely provisional. The documents of the candidates will be verified at the time of interview. In case, any discrepancy with regard to age and other eligibility condition is noticed at the time of interview or thereafter, the candidate(s) shall not be allowed to appear in the interview or where the candidate has already appeared in interview, the candidature shall be deemed to have been cancelled ab-initio.

NOW, THEREFORE, in view of providing false information in the application form, Mr. Sohail Choudhary, Roll No. 5130620 is declared ineligible to appear in interview and his candidature shall and shall be deemed to have been rejected abinito for the post of Assistant Registrar Cooperative advertised vide Notification No. 05-PSC(DR-P) of 2021 dated 11.05.2021.
