**Subject:-Consideration order in compliance to Hon'ble Central Administrative Tribunal order dated 24.11.2021 passed in case titled Dr Syed Khalid Muzzamil & Ors Vs UT of J&K & Ors.**

## **Order**

**Dated 22 .07.2022**

1. Whereas, on the requisition of the Health and Medical Education Department, 1000 posts of Medical Officer were notified vide Advertisement Notification No. 12-PSC (DR-P) of 2018 dated 15.10.2018, for selection of suitable/eligible candidates; and,
2. Whereas, in terms of the recruitment rules governing the service, the selection was to be made by written examination only; and,
3. Whereas, the written examination was held and after the conclusion of the selection process, the list of selected candidates alongwith wait list (50%) was sent to the indenting Department; and,
4. Whereas, the applicants due to their low merit could not find their place either in the select list or in the waiting list; and,
5. Whereas, the applicants filed the instant OA before the Hon'ble Central Administrative Tribunal and the OA was disposed of by the Hon'ble Tribunal vide judgment dated 24.11.2021 as under:

"This matter pertains to appointment of the applicants Dr. S. K. Muzzamil and 8 Others in the Department of Health and Medical Education Department. After hearing the matter to some extent, learned counsel for the parties agreed to dispose of this application with certain directions.

Considering the submission made by the parties counsel, the applicants are directed to file a comprehensive representation before the respondents' within 15 (fifteen days) from the date of receipt of a copy of this order and, in case, such a representation is moved by them, the respondent-authorities is directed to decide and take a decision thereon, by a reasoned and self speaking order within two months and, communicate the decision thereon to the applicants expeditiously



With the above directions, the O.A. No. 330/2020 along with the pending M.A. No. 1444/2021 is disposed of. The parties are directed to bear their own costs”.

6. Whereas, the applicants filed a representation seeking their selection; and,
7. Whereas, the last selected/recommended candidate under OM category has secured 62.00 marks while as the last candidate in the waiting list has secured 59.00 marks; and,
8. Whereas, the merit position of the applicants is as under:

10. Whereas, as is evident from the merit position, none of the applicants has secured marks over and above the last selected/ waiting list candidate; and
11. Whereas, there are 278 candidates between the applicants and the last selected candidate. There are 572 candidates between the applicants and the last candidate in the wait list. In total there are 850 candidates who have secured higher marks than the applicants; and,
12. Whereas, the applicants could not find place either in the main selection list or in the waiting list and rules do not permit preparation of waiting list beyond a certain number (50%).

13. Whereas, the wait list or as in the applicants case the general merit list cannot be a perennial source of appointment and on top of it all the Administrative Department has not made any requisition for any further waiting list.

Now, therefore, in compliance to Hon'ble Central Administrative Tribunal order dated 24.11.2021, passed in case titled Dr Syed Khalid Muzzamil & Ors Vs UT of J&K & Ors, the representation of the applicants has been considered and found devoid of any merit and is, therefore, rejected.
