- i) On 30-07-2022 after 12.00 Noon, the officers/officials visit at the respective centers allotted to them and check the seating arrangements made at the concerned centers as per the guidelines issued to the Supervisors and report discrepancy, if any found by them to the Control Room.
- ii) Report at PSC Office Jammu / Srinagar as the case may be at 7:00 AM sharp on the date of examination for first session & 11.00 AM for second session i.e 31.07.2022 to receive the sensitive material from the



Incharge Control Room established for the purpose and deliver the same to the respective Supervisors against proper receipt.

- iii) At the examination centres, physically count the attendance of the present candidates as well as the invigilation staff including Class-IV employees deployed by the respective Supervisor(s) on the specimen to be provided at the time of delivery of sensitive material and convey the attendance of the candidates verbally to the control room within half an hour after start of examination.
- iv) The incharge team shall be personally responsible for receipt of sensitive material in complete form from the respective Supervisor(s) of the Center(s) after conclusion of examination and handover the same to Incharge Control Room of Secrecy Section at Jammu/Srinagar.
- v) Remain present at the time of opening of sealed packets of question booklets at each center.
- vi) Any problem noticed during the course of examination or related to examination shall be immediately conveyed to the Control Rooms established or to the Controller of Examination on Cell No. 9419133893.


It is further ordered that:-

- i) No leave of any kind shall be entertained, whatsoever reasons may be. Any laxity on the part of any official shall be viewed seriously and shall be reported to the Government.
- ii) The In-charge Control Room after receipt of sensitive material from the concerned officers/officials shall keep the same in the strong room so established for the purpose and keep the room duly locked.
