Whereas, the J&K Public Service Commission, vide Notification No.09-PSC (DR-P) of 2021 dated 03.09.2021, invited online applications from the applicants who are domiciled in the Union Territory of Jammu and Kashmir, for 05 posts (OM=03, RBA=01, SC=01) of Assistant Professor, Math. In response, the Commission received 172 application forms (OM=139, RBA=23, SC=10); and,

Whereas, Rule 45(i) of J&K Public Service Commission (Business and Procedure) Rules, 2021, as amended from time to time, provides that weightage to be given to the academic performance (to be worked out on prorata basis) for the post of Assistant Professor and its equivalent in Higher Education Department is as under:-

Whereas, Rules 45 of J&K Public Service Commission (Business and Procedure) Rules, 2021, as amended from time to time, further provides for shortlisting of the eligible candidates to be called for interview in the ratio of 1:3.
