Subject: Short listing/Rejection of candidature for the post of Assistant Professor, Industrial Chemistry in Higher Education Department notified vide Notification No.09-PSC (DR-P) of 2021 dated 03.09.2021.

Whereas, the J&K Public Service Commission, vide Notification No.09-PSC (DR-P) of 2021 dated 03.09.2021, invited online applications from the applicants who are domiciled in the Union Territory of Jammu and Kashmir, for 01 post in Open Merit (OM) Category of Assistant Professor, Industrial Chemistry. In response, the Commission received 12 application forms; and,

Whereas, Rule 45(i) of J&K Public Service Commission (Business and Procedure) Rules, 2021, provides that weightage to be given to the academic performance (to be worked out on prorata basis) for the post of Assistant Professor and its equivalent in Higher Education Department is as under:-

Whereas, Rules 45 of J&K Public Service Commission (Business and Procedure) Rules, 2021, further provides for shortlisting of the eligible candidates to be called for interview in the ratio of 1:3. As such, 03 candidates, are to be provisionally shortlisted for interview on the basis of academic performance as recorded in the documents submitted by the candidates; and,

Whereas, after compilation of the data with respect to the above given weightage points and the ratio to be adopted for short-listing of candidates for interview, only two (02) candidates in the OM Category have been found eligible, the cut off merit is 38.057.
