Subject:- Representation of Dr. Wani Hamza Bruno & Dr. Kulbir Singh Jat, with regard to selection of Lecture Surgery in Government Medical College Srinagar/Jammu, in pursuance of J&K Public Service Commission Notification No. 15-PSC (DR-S) of 2022 dated 17.08.2022- consideration thereof.

Whereas, the Health & Medical Education Department, vide letter No. ME/GAZ-53/2020 dated 28.09.2020 and No. ME/GAZ-187/2014 dated 11.08.2021, referred 04 posts of Lecturer in the discipline of Surgery in GMC Jammu and GMC Srinagar, for selection of suitable candidates, as per the following break-up:-

Whereas, the J&K Public Service Commission, vide Notification No. 12-PSC (DR-P) of 2021 dated 14.12.2021, advertised the said posts for selection of suitable candidates; and,

Whereas, the Commission received 140 applications (GMC- Jammu: 58, GMC Srinagar: 82), which were scrutinized and 98 eligible candidates (GMC Jammu: 51, GMC Srinagar: 74) were called for interview. Out of 98, 27 candidates applied both for GMC Jammu and GMC Srinagar; and,

Whereas, the interview of the candidates was conducted from 25.07.2022 to 28.07.2022 with the assistance of experts; and,

Whereas, vide Notification No. 15-PSC (DR-S) of 2022 dated 17.08.2022, the merit of the candidates and provisional select list was notified for inviting objections, if any, within a period of 05 (five) days; and,

Whereas, two representations were received the details of which are given below:-

Representation No.1 from Dr Wani Hamza Bruno

Dr Wani Hamza Bruno states that it seems no marks have been awarded to him in the "Paper Presentation Column" which appears an error as he had displayed all paper presentation to the selection committee on the day of interview. He further states that the presentations were accepted by the selection committee and were not paper presentations.

Whereas, the said representation was examined and it was found that the paper presentations have been properly assessed by the experts, however, they have not been accepted, as such, cannot claim any points.

Representation No.2 of Dr. Kulbir Singh Jat


Whereas, in the representation Dr. Kulbir Singh Jat claims that his juniors have been selected in spite of all criteria (Age, Experience, Papers, and Publications) and good interview, as he answered all questions asked by the Interview Board; and,

Whereas, Dr. Kulbir Singh Jat further states that his S.No was 79 in the interview, whileas, it was 80 on the day of interview. He has further requested for rectifying the result and doing justice; and,

Whereas, both of his claims were examined and it was found that there is no discrepancy in award of points to different attributes and segments; and,

Whereas, the change in the S.No from 79 to 80 was also examined and it was found that S.No is only the number on which a candidate was interviewed and any change in this number does not have any bearing on the award roll and the final result.

Now, therefore, on the basis of afore-quoted facts and circumstances, the claims of both of the candidates are hereby found without any merit and hence rejected.
