Subject: Disposal of representations for the post of Assistant Professor, Paediatric Bio-Chemistry in newly created 500 bedded Paediatric Hospital, GMC Srinagar..

NOTICE

Dated:- 19.09.2022

Whereas, the Jammu & Kashmir Public Service Commission, vide Notification No. 05-PSC (DR-P) of 2022 dated 17.01.2022, invited online applications, on prescribed format, from the domiciles of UT of Jammu and Kashmir for 01 post of Assistant Professor, Paediatric Biochemistry, in newly created 500 Bedded Pediatric Hospital, GMC Srinagar, in Health & Medical Education Department; and,

Whereas, 19 candidates applied for the said post. However, the candidature of 11 candidates who were found in-eligible was rejected vide Notice dated 02.09.2022 with the stipulation that if any candidate feels aggrieved with the rejection of his/her candidature, he/she may represent before the Commission within 10 days from the date of issuance of this Notice and no claim whatsoever shall be entertained after the stipulated period; and,

Whereas, in response to the Notice dated 02.09.2022 representations have been received from the following 08 candidates:

Whereas, the representations were examined with reference to the Recruitment Rules of the Department which provides that the Non- MBBS candidates should possess M.Sc (Medical Biochemistry) with Ph.D (Medical Bio-Chemistry).

Whereas, the above candidates from Sr. No. 01 to 07 possess M.Sc Bio-Chemistry which is not the prescribed qualification for the post. While as Sr. No. 08, namely, Saima Mushtaq who is an MBBS candidate has submitted domicile certificate which has been issued in her favour on 29.07.2022 (i.e. after the cut-off date viz 26.03.2022).


Whereas, the representations of the above candidates are, accordingly, disposed of as under:
