Whereas the examination of Excise & Commercial Taxes Pat-II Departmental Examination was conducted w.e.f from 16/03/219 to 20/03/2019; and

Whereas, while declaring the result of the above said examination, the result of Gh. Ahmad Mir bearing Roll No. 62 was kept withheld as the candidate was found involved in unfairmeans case; and

Whereas, as per rules the show cause notice was issued to the candidate vide notice dated: 03/07/2019. The candidate did not respond to the show cause notice issued to him; and

Whereas, in terms of Rule 24 of J&K Public Service Commission (Conduct of Examination) Rules, 2005, the case was submitted to the Committee on Unfairmeans for its recommendations; and

Whereas, after submitting the recommendations made by the Committee on Unfairmeans, the case was placed before the Commission for consideration and decision; and

Whereas, the Commission in its  $32^{nd}$  extra ordinary meeting held on 22/10/2019 under Non-agenda item No. 32.7.2 decided as under:

"the candidate be declared failed in the above examination and also debarred for one year for appearing in any examination to be conducted by the Commission."

Now, therefore, in view of the above the result of the candidate is now declared as under:
