Whereas, the verification/scrutiny of the documents was conducted by the Screening Committee constituted for the purpose and the documents of some candidates were found deficient and accordingly the deficiency notice was issued vide Notice dated 17.07.2019; and

Whereas, the deficient documents were received from the candidates in response to notice dated **17.07.2019** and the said documents were again verified/scrutinized by the Screening Committee for the short-listing of the candidate for interview; and

Whereas, the short-listing of the candidates was conducted as per provisions of Rule 51 of J&K Public Service Commission (Business and Procedure) Rules, 1980 as amended from time to time, which provides for weightage to be given to the Academic performance, outreach and extracurricular activities, special attributes and teaching skills constituting total 57 points. Whereas, the rule 51 of J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time, further provides for the short-listing of eligible candidates to be called for interview in the ratio of 1:3 and as such total **09 candidates are to be shortlisted under OM category for 03 advertised posts, 03 candidates under RBA category for 01 advertised post, 03 candidates under ALC category for <b>01 advertised post** respectively are to be shortlisted on the basis of the Academic Performance, Outreach and extra-curricular activities, Special attributes and Teaching skills as per the weightage details above; and

Whereas, Rule 40 further provides as under:-

Provided further that the candidate (s) who have secured marks equal to those secured by the last candidate, shall also be called for the Interview over and above the number of candidates shortlisted according to ii (a) and ii(b) above.

In a situation, when a reserved category candidate secures, merit equal to or above the cut off merit, in open category, such candidates shall also be called for interview in the respective category.

Whereas, in light of the above rule position one candidate under RBA category has **31.35** merit points which is higher than the last shortlisted candidate of OM category, as such **one candidate over and above** is also shortlisted for interview under **RBA Category**.

Whereas, after compilation of the data with respect to the above weightage points and the ratio to be adopted for short listing of candidates for interview, the cut of merit under **OM Category is 31.00**, **RBA category is 32.04** and **ALC category is 27.08** for the post of Assistant Professor, Persian.

- 1. - 2. The candidature of all the candidates is purely provisional.
- 3. Only eligible candidates possessing requisite qualification prescribed under rules shall be allowed to appear in the interview subject to the conditions that they are within the prescribed age limit on the cut of date.
- 4. The candidates shall produce their original certificates/testimonials on the date interview.
- 5. Attention is also invited to the provisions of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules 1980 amended from time to time, particularly with regard to weightage for higher qualification, which is reproduced as under:-

"The weightage on account of higher qualification shall be admissible for the highest degree possessed by the candidate and not for other higher qualifications down the line. Where one of the higher qualifications possessed by the candidate gets consumed towards the requirement of eligibility the candidate shall be entitled to weightage equivalent to the difference between the two viz, highest degree possessed and the degree considered against eligibility, If the highest degree possessed is itself consumed against the eligibility, no weightage shall flow to the candidates in that eventuality."
