Subject: Revised short listing notice for the post of Assistant Professor, Hindi in Higher Education Department notified vide Notification No. 10-PSc (DR-P) of 2017 dated 27.10.2017.

Whereas, shortlisting/interview schedule was notified vide this Commission's notice dated 14.11.2019 the interview notice for the post of Assistant Professor, Hindi in Higher Education Department, and the left out candidates were asked to represent before the Commission within a period of 10 days from the date of issuance of the notice, in case they feel aggrieved with regard to the cutoff merit indicated against each category or by the non inclusion/rejection of their names in the said notice or as the case may be; and

Whereas, in response to notice dated 14.11.2019, two candidates namely i) Savita Kumari and ii) Sunamika Swara submitted representations which were examined; and

Whereas, on further scrutiny of the record it was observed that one candidate namely Kishore Kumar was shortlisted for interview, at Sr. No. 10 under (OM/SC) category vide notice dated 14.11.2019. His academic/experience points are 26.08 only, but inadvertently 2 additional points was added towards NCC, while he was not possessing such NCC certificate; and

Whereas, representation of Savita Kumari was examined and it was found that she has Ph.D & M.Phil, but has not qualified NET/SET/SLET as such her overall merit point is 22.02 only which is below the cut of merit and accordingly her claim is rejected; and

Whereas, the representation of Ms. Sunamika Swara was examined and found that she is entitled to 28.45 points under OM category while the last cutoff merit as per notice dated 14.11.2019 is 27.83 under OM category; and

Whereas, the name of Kishore Kumar S. No. 10 of notice dated 14.11.2019 is required to be excluded from the shortlisted candidates and in his place the name of Ms. Sunamika is required to be included in the shortlisted candidates for interview for the post of Assistant Professor, Hindi.

Now, therefore, the revised shortlist of candidates to be called for interview for the post of Assistant Professor, Hindi is notified as under:-
