Whereas, vide Notification No.PSC/Exam/01/2019 dated 02.01.2019 and No.PSC/Exam/36/2019 dated 25.04.2019 application forms for appearing in Revenue Services (Executive) Departmental Examination were invited from eligible candidates. In response 733 (666+67) application forms were received, and

Whereas, on scrutiny of the application forms, it was found that out of 733 candidates, 34 (23+11) candidates have not submitted hard copies of their application forms upto the last date i.e. 05.02.2019 & 27.05.2019 and further 14 (10+4) candidates have not submitted their Fee Receipt/Degree/Eligibility Certificate from the Deputy Commissioner of the concerned District. Accordingly, vide Notice No.05/PSC/Exam/2019 dated 28.03.2017, No.09/PSC/Exam/2019 dated 23.04.2019 and Notice No.59/PSC/Exam/2019 dated 04.07.2019, 49 candidates were advised to submit the requisite documents shown against each within a period of seven days from the date of publication of the notice, failing which their candidatures will be rejected; and

Whereas, despite giving ample opportunity for submission of requisite documents, the following 29 candidates failed to submit the requisite documents are hereby rejected for non-submission of required documents shown against each.
