## NOTICE NO. 15/PSC/EXAM/2020 DATED: 14.09.2020

Whereas, vide Notification No.PSC/Exam/04/2019 dated 09.01.2019 and No.PSC/Exam/2019/37 dated 25.04.2019, application forms for appearing in SAC Part-I Departmental Examination were invited from eligible candidates.

- 2. Whereas, in response 248 application forms were received by the Commission within the stipulated time, and;
- 3. Whereas, on scrutiny of these application forms, it was found that out of 248 candidates, 39 candidates have not submitted hard copies of their application forms upto the last date i.e. **13.02.2019** and further 12 candidates have not submitted their Degree/Eligibility Certificate from Director General, Accounts and Treasuries Department.
- 4. Whereas, vide Notice No.03/PSC/Exam/2019 dated 25.03.2017 and Notice No.57/PSC/Exam/2019 dated 01.07.2019, all these 51 candidates were advised to submit the requisite documents shown against each within a period of seven days from the date of publication of the notice, failing which their candidatures will be rejected; and
- 5. Whereas, despite giving ample opportunity for submission of requisite documents, the following 08 candidates failed to submit the requisite documents as indicated against each in the "Reason column":-
