Sub:- Interview/Rejection notice for the post of Assistant Director, Fire & Emergency Services in Fire & Emergency Department.

Whereas, the J&K Public Service Commission vide Notification No. 12 -PSC (DR-P) of 2017 dated 27.11.2017 invited online applications on the prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification for 08 posts (OM= 04, RBA =02, SC =01 & ST =01) of Assistant Director Fire & Emergency Services in Fire & Emergency Department; and

Whereas, the written test was held on 09.03.2019 and 40 candidates who were declared to have qualified the written test were referred to Youth Services & Sports Department for conducting Physical Fitness test of the candidates, in terms of the recruitment rules, and

Whereas, the Physical standards prescribed in the recruitment rules as the eligibility conditions for the post of Assistant Director Fire & Emergency Services are as under:-

Male

Minimum height 05'-06"
Minimum Chest 32"-33.6"

Female


Minimum height 5'-02"

Whereas, as per the Physical Fitness Report furnished by the Youth Services & Sports Department the height measurement of Mr. Stanzin Idong (ST) and Rahul Garhotra (OM) was recorded as 5'-5" and 5'- 4" respectively which is well below the required height of 5'-6" ; and

Whereas, an opportunity of being heard was given to the above candidates and vide letter No. PSC/DR/ADFCS/2008, dated 01.12.2020, they were directed to report at J&K Public Service Commission, Jammu on 01.12.2020 for height measurement and also to present their point of view; and

Whereas, a two member team from J&K Police conducted the height measurement of the above two candidates on 01.12.2020. The team recorded the height measurement of Mr. Stanzin Idong as 5'-4/3/4" and that of Mr. Rahul Garhotra as 5'-4", which is less than the prescribed height measurement as per the recruitment rules, therefore, both these candidates are not eligible for the post of Assistant Director Fire & Emergency Services notified vide Notification No. 12-PSC (DR-P) of 2017 dated 27.11.2017.

Now, therefore, the candidature of Mr. Stanzin Idong and Mr. Rahul Garhotra is hereby rejected and their names shall and shall always be deemed to have been deleted from the interview Notice dated 19.11.2020 for the post of Assistant Director Fire & Emergency Services.
