Shortlisting/rejection of the candidates for the post of Assistant Professor, English in Higher Education Department notified vide notification No.10-PSC (DR-P) of 2017 dated 27.10.2017.

Whereas, the J&K Public Service Commission, vide Notification No.10-PSC (DR-P) of 2017 dated 27.10.2017, invited online applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification for the 86 posts (OM: 17, RBA: 35 & SC:12, ST:14, ALC:07 & SLC:01) of Assistant Professor, English in Higher Education Department and in response to the above said Notification, the Commission has received 363 applications in the said discipline; and

Whereas, the verification/scrutiny of the documents was conducted by the Screening Committee constituted for the purpose and the documents of some candidates were found deficient and accordingly the deficiency notice was issued vide Notice dated **02.08.2019**; and

Whereas, the deficient documents were received from the candidates in response to notice dated **02.08.2019** and the said documents were again verified/scrutinized by the Screening Committee for the short-listing of the candidates for interview; and

Whereas, the short-listing of the candidates has been conducted as per provisions of Rule 51 of J&K Public Service Commission (Business and Procedure) Rules, 1980 as amended from time to time, which provides for weightage to be given to the Academic performance, outreach and extra-curricular activities, special attributes and teaching skills constituting total 57 points, (on pro-rata basis i-iv only) with the break-up tabulated as under:-

Whereas, the rule 51 of J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time, further provides for the short-listing of eligible candidates to be called for interview in the ratio of 1:3 and as such 51 candidates under category for 17 posts, 105 candidates under RBA category for 35 post, 36 candidates under SC category for 12 advertised posts, 42 candidates under ST category for 14 advertised posts, 21 candidates under ALC category for 7 posts and 03 candidates under SLC category for 01 post are to be shortlisted on the basis of the Academic Performance, Outreach and extra-curricular activities, Special attributes and Teaching skills as per the weightage detailed above; and

Whereas, after compilation of the data with respect to the above weightage points and the ratio to be adopted for short listing of candidates for interview, the cut of merit under OM Category is **25.63** and **25.27** against SLC category. Further, the number of Candidates who applied in the categories of RBA, SC, ST & ALC is less than the number of advertised posts, as such all the eligible candidates are to be shortlisted under these categories.

- 2. If any, regarding their claim of having higher percentage points above the cut off merit or as the case may be, within a period of 10 days from the date of issuance of this notice. - 3. Only eligible candidates possessing requisite qualification prescribed under rules shall be allowed to appear in the interview subject to the conditions that they are within the prescribed age limit on the cut of date.
