Subject : **Extension in last date for filling up of SAC-I, SAC/SAFC, Statistical Assistant Course Departmental Examinations - 2020 application forms.**

Whereas, the last date for filling up of online applications for Subordinate Accounts Course-I, Secretariat Assistant Course/Secretariat Assistant Foundation Course & Statistical Assistant Course Departmental Examinations -2020 was 02.12.2020.

Whereas, the results of Subordinate Accounts Course-I, Secretariat Assistant Course & Statistical Assistant Course Departmental Examinations were declared today i.e, on 22.12.2020 and the result of Secretariat Assistant Foundation Course Departmental Examination is yet to be declared.

Whereas, Proviso to Rule 6 (b) of the Jammu and Kashmir Public Service Commission Conduct of Examination Rules, 2005 reads as under:-

“Provided that in case of Departmental Examinations, application forms received after the last date shall be entertained on payment of such late fee per paper s may be prescribed by the Commission from time to time, up to a maximum of 21 days from the last date fixed for receipt of applications.”

In view of the above, the candidates who have been declared as “Failed” in Secretariat Assistant Course, Subordinate Accounts Course-I & Statistical Assistant Course Departmental Examinations and the result for those have been declared today, can apply through OFFLINE mode by 28.12.2020 without late fee. The last date for filling up the application forms for SAFC Departmental Examination is hereby extended upto 28.12.2020. The desirous candidates may fill the application form OFFLINE and submit the same in the office of J&K Public Service Commission at Jammu or Srinagar, as the case may be, by or before 28th of December, 2020.

The **Application Form** must be accompanied by the **Eligibility Certificate** issued by the competent authority and the requisite fee in shape of a **Demand Draft in favour of “CONTROLLER OF EXAMINATIONS, J&K PUBLIC SERVICE COMMISSION”**.

The application fee is Rs. 400/- per paper –

- without late fee**, in case of SAFC candidates whose result is yet to be declared, after the cut-off date i.e., 28.12.2020;
- with late fee** of Rs. 100/- per paper for other candidates, if any.
