Subject: Final Rejection Notice for the post of Assistant Professor, Music in Higher Education Department.

Notice

Dated: 06 .01.2021

WHEREAS, in response to the notification No. 10-PSC(DR-P), 42 application forms were received for the post of Assistant Professor Music, Higher Education Department and;

WHEREAS, on scrutiny of application forms Ms. Shazia Hameed and Mr. Mohammad Younis Bhat were not possessing the requisite qualification (NET/SLET/SET or Ph. D) were declared ineligible for the said post and;

WHEREAS, the candidates represented before the Commission, and claimed that they are eligible for the post of Assistant Professor, Music as they have possessed the alternative prescribed qualification as prescribed (Part-e) of the advertisement notification and;

WHEREAS, the case was further examined in the Commission and it was decided to take up the matter with the Higher Education Department for clarification, and accordingly the matter was taken up with the Higher Education Department, which in response opined as under:

“after examining the documents of the candidates namely Shazia Hameed and Mohammad Younis Bhat, we did not find any document/certificate, which can support their claim for the eligibility. They can only be considered eligible for the above said post if they qualify the above said criteria and are approved with “A” Grade in Classical Music only for All India Radio”.

WHEREAS, on the basis of opinion of the Higher Education Department the candidates namely Shazia Hameed and Mohammad Younis Bhat, were not eligible for the post of Assistant Professor Music as per J&K College Service Recruitment Rules of 2008 notified vide SRO 423 of 2008, amended vide SRO-124 of 21.4.2014 and;

WHEREAS, the candidature of the candidates was rejected vide notice dated 18.11.2020. However in the notice candidates were provided opportunity to file an appeal to the Appellate Authority, J&K PSC, Jammu against the order within 15 days and;


WHEREAS, Mr, Younis Bhat submitted an appeal in which he requested that he may be declared eligible and allow to compete for the same and;

WHEREAS, the appeal of the Mr. Mohammad Younis Bhat was placed before the Appellate Authority for taking a view on the points raised by the candidate in his appeal; and

WHEREAS, the Appellate Authority decided to uphold the recommendations of expert panel of Hr. Education Department which vide its letter No. HE/Coll/AP/Music/2016 dated 14.08.2020 recommended that the applicants do not possess the requisite qualification for the post of Assistant Professor (Music) in Hr. Education Department and;

Now therefore, in view of the opinion of Higher Education Department the appeal of Mr. Mohammad Younis Bhat has been found to be devoid of any merit hence rejected.
