**Subject: Select List for the posts of Assistant Professor (Sociology) in Higher Education Department.**

**Notification No. 05- PSC (DR-S) of 2021**

**Dated: 07.01.2021**

Whereas, the Higher Education Department referred 03 posts [OM:02, & ST:01] of Assistant Professor (Sociology) to the Public Service Commission for being filled up from amongst the suitable candidates; and,

Whereas, the Commission notified these posts vide Notification No. 10-PSC (DR-P) of 2017 dated 27.10.2017; and,

Whereas, in response to the above notification, 317 applications were received. Out of these, 09 eligible candidates were shortlisted and called for interview; and,

Whereas, 02 more candidates were interviewed on the basis of Court directions in various writ petitions, the details of which are given below:-

**WP (C) No. 3020/2019, CM No. 6213/2019 Meenakshi Chandan V/S State & J&K Public Service Commission:-**

*“..... In the meantime, subject to the objections and till next date before the bench, the petitioner be permitted to participate in the process of selection for the post of Assistant Professor (Sociology). This order shall not confer any right of selection on the petitioner. The result of the petitioner shall not be declared till further orders from this court.”*

**WP (C) No. 4070/2019, CM No. 8408/2019 Tsering Nordon V/S State of J&K and others:-**

*“...meanwhile, respondents are directed to permit the petitioner to participate in the interview for the post of Assistant Professor Sociology advertised vide advertisement Notice dated 27.10.2017.”*

Whereas, the interview of the shortlisted candidates was conducted on 18.11.2020 & 05.01.2021 with the assistance of subject experts.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the merit of the candidates who have appeared in the interview is enclosed as **Annexure-“A”** to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

**Note:-**

1. The Commission reserves the right to have certificates/documents of the candidate verified, if it is at any stage found expedient to do so. The Selection of the candidate is purely provisional and is subject to the outcome of writ petitions pending before any competent Court of law.
2. In pursuance of Rule 51 of J&K PSC (Business & Procedure) Rule, 1980 and as reiterated by the Commission in the 20th extra ordinary meeting held on 20.06.2019, candidates having NET are entitled for points only from the highest qualification amongst M.Phil/Ph.D and where Ph.D itself is consumed towards eligibility the candidates are not entitled for any points.
3. The select list is provisional. Any objection may be submitted to the Commission within one week for examination and disposal. No claim will be entertained after one week from the date of issuance of Notification.
