Whereas, the name of Zaheer Abass S/o Mohd Sharief S.No. 17 in Notice dated 14.11.2019 is required to be excluded from the shortlisted candidates and in his place the name of Syed Zahigam Abbas S/o S Haider Shah is required to be included in the shortlisted candidates to be called for interview for the post of Assistant Professor, Persian, in Higher Education Department; and
