Whereas, the J&K Public Service Commission, vide Notification No.13-PSC (DR) of 2017 dated 27.11.2017 invited online applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification for the **01 posts** of **Curator** in OM Category the Directorate of Archives, Archaeology and Museum in Culture Department; and

Whereas, In response, the Commission received **33** application forms in the said discipline; and

Whereas, the written test of the candidates who had applied for the post of Curator in the Directorate of Archives, Archaeology and Museum Department was conducted on 13.10.2019; and

Whereas, the result of the written test was declared on 23.10.2019 vide Notification No. PSC/Exam/2019/72 dated 23.10.2019 and 05 candidates were declared to have qualified the written test; and

Whereas, the qualification for the post of Curator was prescribed as MA in History with Degree/Diploma in Archaeology/Museology or Archives; and

Whereas, the scrutiny of the documents of candidates who had qualified the written test revealed that the following candidates do not possess the requisite qualification for the post of Curator, as indicated against each:-

02	Ms. Jigmet Wangmo D/o Tsering Tondup	1130032	Does not possess the Master Degree in History
