Subject:- Shortlisting of the candidates for the post of Assistant Professor, Public Administration in Higher Education Department notified vide Notification No.10-PSC (DR-P) of 2017 dated 27.10.2017.

Notice

Whereas, the J&K Public Service Commission, vide Notification No. **10-PSC (DR-P) of 2017 dated 27.10.2017**, invited online applications on prescribed format from the permanent residents of Jammu & Kashmir for the 10 posts of Assistant Professor, Public Administration in Higher Education Department, possessing the prescribed qualification. In response to the said Notification, the Commission received 74 application forms; and

Whereas, the verification/scrutiny of the documents was conducted by the Screening Committee constituted for the purpose and it was found 38 candidates were not possessing the relevant qualification, as such their candidature has been rejected vide Notice dated 16.01.2019, further 36 candidates were found deficient of documents who were advised to submit the deficient documents; and

Whereas, the deficient documents were received from 14 candidates, 05 candidates whose candidature was rejected also submitted the documents/representation against their rejection; and


Whereas, it was noted that there is no clarity on equivalence of various degrees with the minimum prescribed qualification, M.phil and P.hD, different from the relevant discipline and conduct of

NET/SLET/SET in various disciplines by UGC,CSIR/AIU and ICAR/ASRB; and

Whereas, the matter was taken up with the Higher Education Department for clarification; and

Whereas, the Higher Education Department furnished the Minutes of the Equivalence Committee held on 10.9.2020. As per the decision of the Equivalence Committee, the Degrees obtained in Political Science, Business Administration, JRF in Management for the post of Assistant Professor, Public Administration, are not equivalent to the qualification prescribed for the post viz. Master's Degree in relevant subject i.e. Public Administration; and

Whereas, on the basic decision of the Equivalence Committee the short-listing of the candidates has been conducted as per provisions of Rule 51 of J&K Public Service Commission (Business and Procedure) Rules, 1980, as amended from time to time, which provides for weightage to be given to the Academic performance, outreach and extra-curricular activities, special attributes and teaching skills constituting 57 points, (on pro-rata basis i-iv only) with the break-up tabulated as under:-

Whereas, the rule 51 of J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time, further provides for the short-listing of eligible candidates to be called for interview in the ratio of 1:3 and as such 15 candidates under Open category for 05 posts, **06 candidates** under **RBA category for 02 post**, **03 candidates** under **SC category** for **01 post**, **03 candidates** under **ST category** for **01 and 03 candidates** under **ALC category** for **01 posts** are to be shortlisted on the basis of the Academic Performance, Outreach and extra-curricular activities, Special attributes and Teaching skills as per the weightage detailed above; and

Whereas, the ratio of 1:3 could not be followed in respect of categories of OM,RBA,SC, due to less number of eligible candidates in these categories.

Whereas, after compilation of the data with respect to the above weightage points and the ratio to be adopted for short listing of candidates for interview, the cut of merit under OM Category is 22.61, RBA 20.74, SC 21.19 and ST 24.16. No candidate under ALC category is eligible for the post of Assistant Professor Public Administration.

Now, therefore, the following candidates are hereby shortlisted for the post of Assistant Professor, Public Administration:-

Note

1. In pursuance of Rule 51 of J&K PSC(Business & Procedure) Rules,1981 and as reiterated by the Commission in the 20th extra ordinary meeting held on 20.6.2019 candidates having NET are entitled for points only from the highest qualifications amongst M.Phil. /Ph.D. and where Ph.D. itself is consumed towards eligibility the candidates are not entitled for any points.
2. If any candidate feels aggrieved with respect to cut off merit under various categories or non-inclusion/rejection of his name in the above list of shortlisted candidates for interview, he/she may represent before the Commission alongwith the proof of documents. If any, regarding their claim of having higher percentage points above the cut off merit or as the case may be, within a period of 10 days from the date of issuance of this notice. No claim what so ever shall be entertained after expiry of the Notice period.
3. Only eligible candidates possessing requisite qualification prescribed under rules shall be allowed to appear in the interview subject to the conditions that they are within the prescribed age limit on the cut of date.
