

However, the candidates can file an appeal before the Appellant Authority of the Commission, as envisaged under Rule 31 of the J&K Public Service Commission (Business and Procedure) Rules 1980 at Commission's office, Jammu within **10 days** from the issuance of this notice, after which, no appeal, whatsoever, shall be entertained.
