SHOW CAUSE NOTICE

Whereas, J&K Public Service Commission vide Notification No. 01-PSC (DR-P) of 2020 dated: 30.07.2020 invited applications for the posts of Medical Officer (Allopathic) in Health & Family Welfare Department; and

Whereas, you applied for the post of Medical Officer (Allopathic) in Health & Family Welfare Department in pursuance to the said Notification vide Application No.20010100102276; and

Whereas, on the basis of your application form submitted by you through online, you were allowed to appear in the said examination conducted on 01.11.2020; and

Whereas, the result of Written Test was declared on 10.11.2020 and among other candidates you was also directed to get your documents verified at J&K Public service Commission offices at Jammu and Srinagar w.e.f 17.11.2020 to 28.11.2020; and

Whereas, at the time of verification of documents, on self-declaration form you have mentioned your age as **40 years** as on 01.01.2020 and accordingly, your name was recommended to the intending department for the post of Medical Officer (Allopathic) vide Notification No. PSC/Exam/2020/43 dated 14.12.2020; and

Whereas, as per Notification the maximum age prescribed under OM category was 40 years as on 01.01.2020; and

Whereas, at the time of online application your age as on 01.01.2020 was **40 years 10 months & 17 days**; and

Whereas, your candidature was accordingly cancelled vide order No. 11-E PSC of 2021 dated: 09.02.2021; and

Whereas, you have misrepresented/concealed the facts regarding your age at the time of verification of documents and filling of application from deliberately to get age relaxation and selection, which is an offence as prescribed under rule 20 (e) of J&K Public Service Commission (Conduct of Examination) Rules, 2005.

In view of the above, you are hereby afforded an opportunity of being heard, as such you are directed to present before the Controller of Examinations, J&K Public Service Commission by or before 03.03.2021 to show cause why action as warranted under rules may not be taken against you and you may not be debarred from appearing in future examinations/selections to be conducted by the Commission.
