Whereas, Health & Medical Education Department vide letter No. ME/GAZ/187/2014 dated 12.02.2019 and 21.01.2019 referred 01 post of Lecturer each under Open Merit and RBA category in the discipline of Physiology (GMC-Jammu) for selection of suitable candidates; and

Whereas, J&K Public Service Commission vide Notification No. 01-PSC (DR-P) of 2019 dated 07.01.2019 advertised 01 post under RBA category and simultaneously vide Notification No. 03-PSC (DR-P) of 2019 dated 19.03.2019 advertised 01 post under Open merit also; and

Whereas, 12 applications were received against Notification No. 01-PSC (DR-P) of 2019 dated 07.01.2019 and 11 applications were against Notification No. 03-PSC (DR-P) of 2019 dated 19.03.2019. The applications were scrutinized and accordingly 07 and 06 number of eligible candidates were called for interview against Notification No. 01-PSC (DR-P) of 2019 dated 07.01.2019 and No. 03-PSC (DR-P) of 2019 dated 19.03.2019 respectively; and

Whereas, the interview of the shortlisted candidates was conducted on 17.12.2020 with the assistance of subject experts; and,

Whereas, 01 more candidate was interviewed on the basis of Court directions, operative part of which is reproduced below:-

**SWP NO: 757/2019, IA NO: 01/2019 TITLED: DR NEENA SHARMA V/S STATE & ORS**

***“ In the meantime, subject to objections, it is ordered that the petitioner will be permitted to participate in the selection process for the post of Lecturer in the Department of Physiology in pursuance to advertisement notice dated: 19.03.2019. The result of the petitioner however, shall not be declared till further orders.”***

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the merit of the

candidates who have appeared in the interview is enclosed as **Annexure-"A"** to this Notification. However, the result of the petitioner shall not be declared till the directions from the Hon'ble High Court in the SWP No.757/2019, IA NO: 01/2019 Titled Dr. Neena Sharma V/S State &Ors and shall be kept under sealed cover.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

1. The Commission reserves the right to have certificates/documents of the candidate verified, if it is at any stage found expedient to do so. The Selection of the candidate is purely provisional and is subject to the outcome of writ petitions pending before any competent Court of law.
