Whereas, the representations submitted by the above candidates were scrutinized/examined in the Commission and the decision taken therein is indicated against each:

S.No.	Name of the Candidate	Decision
1	Dr. Masrat Jan	The claim for award of 03 points for M. Phil is not covered under rules. Further, the experience has been acquired during Ph.D Course; as such no weightage can be given for such experience. <b><u>Hence representation is rejected.</u></b>
2	Barkat Hamid	The experience achieved during Ph. D course cannot be considered. However, experience achieved prior to admission/after completion of Ph.D course has been considered. <b><u>Hence, the representation is entertained.</u></b>

3.	Dr. Firdous	<b><u>The representation has been considered.</u></b>
4.	Mushtaq Hussain	The claim of 03 points of M. Phil is not covered under rules. <b><u>Hence, representation is rejected.</u></b>
5.	Dr. Muzafar Iqbal	The claim of 03 points of M.Phil is not covered under rules. <b><u>Hence, representation is rejected.</u></b>
6.	Liyaqat Ali	PG had been done in 2012. The CGPA formula issued by the University of Kashmir in 2014 has a prospective effect, as such, <b><u>claim is rejected.</u></b>
