
Whereas, the Commission vide Notification No. PSC/Exam/Calendar/2021/04 dated 22.01.2021 notified a tentative schedule/calendar of Competitive Examinations for conduct of Written/Recruitment Test (RTS)-2021; and

Whereas, the Industries & Commerce Department vide No. IND/MNG/17/2013 letter dated 23.02.2021, conveyed that the freshly indented 06 posts of Geologist Grade-III are not available for recruitment in addition to the already referred posts with regard to which J&K PSC started the recruitment/selection process in the year 2014, vide advertisement notification dated 26.11.2014, but the same was put on hold by Hon'ble Court vide an interim Order dated 12.06.2015 in SWP No.1829/2015 titled Ashish Bhardwaj & Others Vs State of J&K and Ors and as such requested the Commission to treat the fresh indent furnished vide letter dated 09.02.2021 as null and void and withdrawn ab-initio; and

Whereas, the Transport Department has not furnished till date the Syllabus for Written Test for the Post of Works Manger Examination 2021, which was tentatively scheduled to be held w.e.f. 23.05.2021.

Therefore, In view of above, it is for the information of all the concerned candidates that the subject examination(s) which were scheduled to be held on 23.05.2021 are hereby deferred till further orders.
