Shortlisting/Rejection of the candidates for the post of **Assistant Professor**, **Nutrition and Dietetics** in Higher Education Department notified vide Notification No.10-PSC(DR-P) of 2017 dated 27.10.2017.

1. Whereas, the J&K Public Service Commission, vide Notification No. 10-PSC(DR-P) of 2017 dated 27.10.2017, invited online application forms, on prescribed format, from the permanent residents of Jammu & Kashmir for the 02 posts of Assistant Professor, Nutrition and Dietetics in Higher Education Department, possessing the prescribed qualification, i.e. Master's Degree level in the relevant subject from an Indian University, or an equivalent degree from an accredited foreign University. In response, the Commission received 24 application forms; and

- 2. Whereas, the verification/scrutiny of the documents was conducted by the Screening Committee constituted for the purpose and some candidates were found deficient in respect of some candidates. Accordingly, vide Notice dated 01.07.2019, these candidates were advised to submit the deficient documents; and
- 3. Whereas, in response to the above Notice, the deficient documents were received from some of the candidates, which were further verified/scrutinized for short-listing of the candidates; and
- 4. Whereas, it was noted that there is no clarity on equivalence of various degrees with the minimum prescribed qualification; and
- 5. Whereas, the matter was taken up with the Higher Education Department for clarification; and
- 6. Whereas, the Higher Education Department furnished the Minutes of the meeting of the Equivalence Committee held on 10.09.2020. As per the decision of the Equivalence Committee, the Master's Degrees obtained in Dietetics and Food Service Management, Fisheries Science in Fish, Nutrition & Food Technology are not equivalent to the qualification prescribed for the post viz. Master's Degree in relevant subject i.e. **Nutrition and Dietetics**; and
- 7. Whereas, the shortlisting of the candidates has been done on the basis of the decision of the Equivalence Committeeand as per provisions of Rule 51 of J&K Public Service Commission (Business and Procedure) Rules, 1980, as amended from time to time, which provides for weightage to be given to the Academic Performance, outreach and extra-curricular activities, special attributes and teaching skills constituting 57 points (on pro-rata basis i-iv only) with the break-up tabulated as under:-

- 1. In pursuance of Rule 51 of J&K PSC (Business & Procedure) Rules, 1981 and as reiterated by the Commission in the 20^{th} extra ordinary meeting held on 20.06.2019, the following points/decision has been taken:
 - a) A candidate with Ph.D but without NET/SET/SLET is not entitled for any weightage points.

- b) A candidate with NET/SET/SLET +M.Phil+Ph.D shall be entitled for (06)weightage points only for higher qualification in the hierarchy.
- c) A candidate with NET/SET/SLET +M.Phil shall be entitled for 03 weightage points for M.Phil.
- d) A candidate who has Ph.D + M.Phil but without NET/SET/SLET shall not be entitled for any weightage points.
- e) A candidate having NET/SET/SLET +Ph.D, but without M.Phil shall be entitled for 06 weightage points.
- 2. If any candidate feels aggrieved with respect to cut off merit under various categories or non-inclusion/rejection of his name in the above list of shortlisted candidates for interview, he/she may represent before the Commission alongwith the proof of documents. If any, regarding their claim of having higher percentage points above the cut off merit or as the case may be, within a period of 10 days from the date of issuance of this notice. No claim what so ever shall be entertained after expiry of the Notice period.
- 3. Only eligible candidates possessing requisite qualification prescribed under rules shall be allowed to appear in the interview subject to the conditions that they are within the prescribed age limit on the cut of date.
